**PERMIT IS VALID FOR ONE CALENDAR YEAR BEGINNING JANUARY 1, AND ENDING DECEMBER 31.** Permits purchased after January 1 in any given year will also expire December 31 of that year; and permit fees will not be pro-rated. Permits are required for chickens permitted in one family (R-1) homes only. A permit is not required for chickens permitted in Agriculture/Rural Estate (AG/RE) district.

<b>Neighborhood Notification</b>			
Before a permit is issued for the keeping of chickens, the Clerk's office shall notify, in writing, owners and occupants of properties within 100 feet of the property where chickens will be kept. If any owner or occupant protest the within ten business days, the permit may only be issued by the Clerk after referral to the License and Permits Committee.

I hereby certify that the information submitted is true and correct to the best of knowledge. In submitting the permit application, I acknowledge and agree the application is subject to all regulations found in Chapter 10 Animals in the City of Tomahawk Municipal Code and further agree to fully comply with said regulations. If the requirements of Chapter 10, Animals are not complied with, the City of Tomahawk may revoke any permit granted.
